The following environmental management measures and projects have been completed or implemented since the 2019 baseline. The carbon emissions are now the same as our baseline year of 2019. However, this is set against an increase in our business turnover of 35%

The Carbon Reduction plans we have implemented or are working towards include:

80% of our vehicles are now all Electric 100% of office and warehouse lighting is LED / PIR 100% recycling of unusable Cardboard & Plastic 50% reduction in waste to landfill All plastic is 30%+ recycled composition. Certification to ISO14001 In the future we hope to implement further measures such as:

100% of fleet are Electric.

All deliveries made via electric vehicles

Air Freight transportation removed

Solar panels installed.

Product manufacturing moved to UK

Zero waste to landfill

All cardboard / plastic packaging is 100% recycled composition.
